**Explanation of Responses:**

- The Restricted Stock Units were granted pursuant to the AMN Healthcare Equity Plan. Each Restricted Stock Unit represents a contingent right to receive one share of Common Stock.
- The Restricted Stock Units vest in the incremental amount of 33% on the first anniversary of the grant; 34% on the earlier of (i) July 17, 2008 and (ii) the date of the Company's 2008 Annual Meeting of Stockholders; and 33% on the earlier of (i) July 17, 2009 and (ii) the date of the Company's 2009 Annual Meeting of Stockholders.
- The Restricted Stock Units vest in the incremental amount of 33% on the earlier of (i) April 18, 2008 or (ii) the date of the Company's 2008 Annual Meeting of Stockholders; 34% on the earlier of (i) April 18, 2009 or (ii) the date of the Company's 2009 Annual Meeting of Stockholders; and 33% on the earlier of (i) April 18, 2010 or (ii) the date of the Company's 2010 Annual Meeting of Stockholders.
- The Stock Appreciation Rights were granted pursuant to the AMN Healthcare Equity Plan. The Stock Appreciation Rights vest on the first anniversary of the grant date.
- The Stock Appreciation Rights vest on the earlier of (i) April 18, 2008 or (ii) the Company's Annual Meeting of Stockholders.
