- The Restricted Stock Units, granted on September 21, 2010, vest in the incremental amount of 33% on the earlier of the first anniversary of the Grant Date or the date of the Company's annual meeting of stockholders the first year following the Grant Date, 34% on the earlier of the second anniversary of the Grant Date or the date of the Company's annual meeting of stockholders the second year following the Grant Date and 33% on the earlier of the third anniversary of the Grant. Date or the date of the Company's annual meeting of stockholders the third year following the Grant Date.
- Restricted Stock Units do not have an expiration date.
- The Restricted Stock Units were granted pursuant to the AMN Healthcare Equity Plan. Each Restricted Stock Unit represents a contingent right to receive one share of Common Stock.
- The Stock Appreciation Rights were granted on September 21, 2010 pursuant to the AMN Healthcare Equity Plan and vest 100% on and after the earlier of the Company's 2011 Annual Shareholders Meeting or the first annual anniversary of the Grant Date.
- The Restricted Stock Units were granted on April 12, 2011 and vest on the earlier of (i) April 12, 2012 or (ii) the date of the Company's 2012 Annual Meeting of Stockholders.
- Common Stock acquired on the vesting of Restricted Stock Units.
