Explanation of Responses:

- A Stock-Settled Appreciation Right ("SSAR") entitles the Grantee to the right to receive shares of the Company's Common Stock ("Stock") having a value equal to the excess of the Fair Market Value of the closing price of the Stock on the trading day prior to the date of exercise over the Exercise Price multiplied by the number of SSARs exercised. This number set forth in this row represents the difference between the number of SSARs exercised (5,168) and the number of shares of Stock issued as a result of the exercise (3,688).
- The Stock Appreciation Rights set forth in this row were granted on April 8, 2008 and vested over three years on the anniversary of the grant date in increments of 33%, 34% and 33%, respectively.
